



CURFEW NOTIFICATION

The Marcus Hook Police Department is reminding residents about curfew hours for minors. Curfew hours in Marcus Hook, PA, are generally for individuals under the age of 18 years of age and are from 8:00 p.m. of any day and before 5:00 a.m. of the following day.

The primary purpose of curfew is to limit the presence of minors in public places during specific hours, typically at night. This is often intended to reduce the risk of youth being involved in or becoming victims of criminal activity, as well as to assist parents and guardians in supervising their children. Curfews can also be implemented in emergencies or to address specific community concerns, like managing crowds that are of a public safety concern or reducing disturbances. See the borough's curfew ordinance below for informational purposes.

CURFEW NOTIFICATION CONTINUED

Chapter 83-Curfew

§ 83-1 Curfew established for certain minors.

For the protection of the health, morals and welfare of the children of the Borough of Marcus Hook, it shall be unlawful for any child or children under the age of 18 years to be on the streets of the Borough alone or in groups later than 8:00 p.m. of any day and before 5:00 a.m. of the following day. ~~Except during the days between the Memorial Day and Labor Day holidays, the curfew shall be extended to 9:00 p.m. instead of 8:00 p.m.~~



§ 83-2 Violations by parents.

It shall be unlawful for any parent or parents to permit children under the age of 18 years to be on the streets of the Borough of Marcus Hook either alone or in groups after 8:00 p.m. of any day and before 5:00 a.m. of the following day. ~~Except during the days between the Memorial Day and Labor Day holidays, the curfew shall be extended to 9:00 p.m. instead of 8:00 p.m.~~

§ 83-3 Violations by minors.

It shall be unlawful for any child or children under the age of 18 years to be alone or in groups on the streets of the Borough of Marcus Hook after the hour of 8:00 p.m. of any day and before 5:00 a.m. of the following day. ~~Except during the days between the Memorial Day and Labor Day holidays, the curfew shall be extended to 9:00 p.m. instead of 8:00 p.m.~~

§ 83-4 Penalties for parents.

Any parent or parents violating the terms of this chapter and permitting their child or children to be on the streets of the Borough of Marcus Hook after 8:00 p.m. of any day and before 5:00 a.m. of the following day shall, upon conviction thereof, be punishable for each offense by a fine of up to the maximum amount provided from time to time by state statute. ~~Except during the days between the Memorial Day and Labor Day holidays, the curfew shall be extended to 9:00 p.m. instead of 8:00 p.m.~~

§ 83-5 Disposition of minor offenders.

Any child or children violating the terms of this chapter shall, upon conviction thereof before any District Justice of Delaware County, be delivered by the said Justice to the juvenile authorities of the County of Delaware.


2025 MEMORIAL DAY PARADE





PROPERTY MAINTENANCE - GRASS & WEEDS

Weeds and Grass Code 73-1

It Shall be unlawful for any person, persons or corporation, owners and/ or occupiers of land in the borough of Marcus Hook, to permit the growth of grass or weeds upon said lands in excess of Six inches in height or to plant or permit to grow any vegetation to create unpleasant or obnoxious odors or to create or produce pollen detrimental to the health of any citizen or citizens of the Borough.

Height of Hedges; obstructing view of vehicles Code 73-2

It Shall also be unlawful for any person, person, persons or corporation, owners and/or occupiers of land in the borough of Marcus Hook, to grow or permit to grow any hedge, bushes or vegetation which encroaches upon the sidewalk, roadways, lane or streets of the borough of Marcus Hook, or to permit any hedge, bushes or vegetation growing along any sidewalk, street lane or road in the borough of Marcus Hook to EXCEED 4 Feet in height, or to permit the same grow in such a manner as to obstruct the view of vehicles approaching in the highway.

Notice to Cut or Remove Vegetation Code 73-3

Any person, persons or corporations violating the provisions of this chapter shall upon receipt of 5 days' notice from the Board of Health, Code Enforcement Officer or Police Department, remove, cut or destroy any such grass, weeds or vegetation growing in violation of the terms of this Chapter.

Pool and Spas Code 157-23 section F

Pool and Spas shall be maintained so the water remains free and clear of pollutants and debris and shall comply with the regulation set forth in the applicable code(s).

Please be reminded that you need to clean up the grass clippings from all walkways after you cut your grass.

Also if you cut your grass to the required height after a fine has been imposed you are still required to pay the fine.



NEW PA “PAUL MILLER’S LAW” FINES DRIVERS CAUGHT HOLDING PHONES, EVEN WHEN STOPPED AT A RED LIGHT

In Pennsylvania, it is illegal to use a handheld cell phone while driving, even at red lights or when stopped in traffic. This ban, known as Paul Miller's Law, will take effect on June 5, 2025. Drivers are also prohibited from holding a phone in any part of their body while driving. Exceptions to the law include using a device for navigation or directions, or when communicating with law enforcement or emergency services to prevent injury

Here's a more detailed breakdown:

Ban on Handheld Use:

Drivers are prohibited from holding a cellphone or any other handheld device in their hand while driving.

NO EXCEPTIONS FOR STOPPED VEHICLES:

The ban applies whether the vehicle is in motion or stopped, including at traffic lights and stop signs. 

EXCEPTIONS FOR EMERGENCY COMMUNICATION:

There is an exception for communicating with law enforcement or emergency services to prevent injury to a person or property.

GPS NAVIGATION AND INTEGRATED SYSTEMS ALLOWED:

Using a device for navigation or a system physically or electronically integrated into the vehicle is permitted.

PENALTIES:

For the first 12 months, violators will receive a written warning. After that, they will face a \$50 fine plus court costs and other fees.

NO POINTS ON LICENSE:

The violation does not result in any points on the driver's license.

Important Note: This law applies to all drivers, including those with commercial licenses, but the violation will be recorded on commercial drivers' records as a non-sanction violation.

MARCUS HOOK HISTORY CORNER

So how did Great Britain lose its rights to the American Viscose Company in Marcus Hook?

After his re-election in 1940, the Roosevelt administration was openly committed to helping the British cause. However, the American public and Congress needed persuasion. The United States in general was anti-Hitler, but also considered Britain and imperialist power that had brought many of its problems upon itself.

Following a visit to Washington in July 1940 seeking American help, Sir Frederick Phillips a British Treasury official, presented Henry Morgenthau, Roosevelt's Treasury Secretary, with a list of British holdings in the United States. At the top of the list - above Shell Oil, Lever Brothers, Dunlop Tire & Rubber, and Brown & Williamson Tobacco - was American Viscose Company (AVC).

"How could Americans justify providing assistance to the British when the latter has such important assets in the U.S.?" Morgenthau asked.

Rather than send money or sell arms -forbidden by the Neutrality Act- FDR proposed that the U.S. "Lend" war material (ships, aircraft, tanks, munitions) in exchange for (in the case of Britain) "leases" to bases in Newfoundland, Bermuda and the West Indies.

On December 7, 1940, British Prime Minister Winston Churchill pressed Roosevelt in a 15-page letter for American help. In his December 29, 1940 Fireside Chat radio broadcast, President Roosevelt proclaimed the United States would be the "Arsenal of Democracy" and proposed selling munitions to Britain and Canada. Isolationists were strongly opposed, warning it would result in American involvement with what was considered by most Americans as an essentially European conflict. In time, opinion shifted as increasing numbers of Americans began to consider the advantage of funding the British war against Germany, while staying free of the hostilities themselves. Propaganda showing the devastation of British cities during "The Blitz", as well as popular depictions of Germans as savage also rallied public opinion to the Allies, especially after Germany conquered France.

It became clear that Britain had to demonstrate to a still isolationist U.S. public and Congress that Great Britain was not asking for funds from Americans while it has its own sizable resources in the U.S. After a decade of neutrality, Roosevelt knew that the change to Allied support must be gradual, given the support for isolationism in the country.

So it was that the Lend-Lease Act, passed in 1941, allowed the United States to supply war materials to Allied nations, including Great Britain and the Soviet Union, without requiring immediate payment, effectively providing aid while maintaining a semblance of neutrality.

President Roosevelt signed the Lend-Lease bill into law on March 11, 1941. It permitted him to "sell, transfer title to, exchange, lease, lend, or otherwise dispose of, to any such government [whose defense the President deems vital to the defense of the United States] any defense article." In April, this policy was extended to China, and in October to the Soviet Union, which was attacked by Germany on June 22, 1941. Roosevelt approved \$1 billion in Lend-Lease aid to Britain at the end of October 1941.

In 1941 the Roosevelt administration demanded that England give up some assets to prove to a skeptical U.S. public that it really needed help. The White House chose Britain's largest, most profitable U.S. holding: American Viscose Company of Marcus Hook. It was sold to U.S. bankers for \$62.3 million, a fraction of its net worth, and then resold.

Some Britain's - most notably Winston Churchill - thought they had been fleeced.

The history of the company begins with rayon, the modern term for an artificial fiber invented by a Swiss chemist in 1855. First called "artificial silk," rayon is produced from wood pulp. Other inventors tinkered with the process until in 1894 a group of English chemists patented a process that produced a commercially viable fabric they called viscose.

"Viscose" was a derivation of viscosity the scientific measure of a fluid's thickness. The wood pulp from which the fabric was spun was viscous, or thick. Among artificial fibers rayon was the pioneer - far ahead of nylon (first produced in 1935), Dacron (1941), olefin (1949), polyester (1953) and others. The textile industry adopted the name rayon in 1924.

Rayon was primarily used in clothing, furnishings, industry (medical products and tire cord), and personal disposals like tampons and diapers. Today, its production has declined because its production generates a large amount of sulfurous waste.

A British textile company, Samuel Courtauld, Ltd., was one of several European firms interested in developing man-made fibers. The market grew steadily and a Samuel Agar Salvage became Courtauld's U.S. sales representative. In 1908 he proposed that Courtauld purchase the American manufacturing rights for rayon (which was then called "artificial silk") and open a plant in the U.S. He recommended a site in Marcus Hook. The American Viscose Company started operation seven days before Christmas in 1910. This was the first artificial fiber manufacturing facility in North America.

Previously a resort and center of shipping and shad fishing, Marcus Hook had tilted toward heavy industry in the early 20th century. By 1910, it was also home to oil refineries operated by Sun and Union petroleum companies.

It took some time for the men who came over from England to train locals on how to handle the sticky, wet yarn. The business quickly outgrew the capacity of the Marcus Hook plant. Additional facilities were then built in Roanoke, VA; Lewistown, PA; Parkersburg, W.VA.; and Front Royal, VA. Marcus Hook remained the headquarters.

Courtauld's patent expired in 1920, and Dupont entered the field. Competition drove down prices but expanded the market. By 1940, U.S. consumption of rayon was 488 million pounds annually; up from 61 million in 1927. And American Viscose Company had 31 percent of the market.

Salvage was made a Courtauld vice president, knighted and grew rich. Marcus Hook profited, too.

The early growth of the company demanded the hiring of skilled long-term workers which put AVC in competition with other regional industries. This led to the company's decision to build a highly attractive model planned community where its employees could live at subsidized rates. With its Flemish, Tudor and Craftsman architecture, the 20-acre Viscose Village was constructed in phases between 1912 and 1915. It consisted of 261 homes, two boarding houses, and a general store. All of these buildings remain intact today.

Despite its success – or perhaps because of it – American Viscose Company became vulnerable to the combined clout of the White House and investment banker J.P. Morgan, which had entwined itself into the power structure of many countries – especially the U.S., England and France. Even after the company split into a commercial banking division (J.P. Morgan) and investment banking (Morgan Stanley) its clout only partially diminished. Both were involved when Roosevelt and his treasury secretary, Henry Morgenthau, decided that American Viscose had to go.

The British capitulated and the sale was managed by Morgan Stanley. It was said that American Viscose Company Chairman Samuel Courtauld behaved "in exemplary fashion," wrote business historian Ron Chernow. "He only asked one question: Was the sale essential in the national interest, whatever the hardship on him and his company?"

After the war, Churchill described the incident in cynical terms in his memoirs. It was Churchill's conviction that American Viscose had brought far less than it was worth.

After the war and bitter litigation Courtauld received additional compensation from the British government.
