APPLICATION FOR USE OF ATHLETIC FIELDS CONDITIONS

1. PERMITS ARE NOT TRANSFERABLE. Field privileges apply only to the sponsoring group as specified above.
2. It shall be unlawful for any person to drink or have in his/her possession, in any park, any alcoholic beverage. No intoxicated person shall be permitted in a park.
3. In view of the fact that the parks have been acquired and maintained primarily for the use of residents and taxpayers of the Borough of Marcus Hook, the Borough Council, or any person designated by it, shall have the right to grant priority status to any group or organization comprised of players, 50% of whom are Borough residents.
4. Any person to whom a permit is issued must be present, or designate a responsible party to be present, on the specified time and date as set forth on the issued permit. The responsible party shall, upon request, present the permit to the proper authority.
5. Affiliated groups and organizations must provide the Borough of Marcus Hook with a Certificate of Insurance naming the Borough of Marcus Hook as an additional insured on their general liability insurance policy.
6. Any person to whom a permit is issued shall be liable for any damage sustained by any reason due to the negligence or fault of the applicant or any member of his sponsoring group or organization.
7. No person in a park shall paste, glue, tack, or otherwise post any sign, placard, advertisement or inscription whatever, on any tree, building, fence, playground equipment or other property in a park.
8. The activities of the organization or group must be confined to the area assigned.
9. Permit charges will be enforced for those facilities requiring a Rental Fee. Such fees shall be paid at the time of the application. No refunds will be granted.
10. Permits for outdoor facilities will be offered under the following Rain Date Policy: No individual, group or organization will be allowed to request Rain Dates for any activity. Permits will only be issued on a one time basis. If an activity is postponed/cancelled, a group will be permitted to reschedule a postponed activity with the Department of Recreation depending on the available of that facility.
11. The use of profane or indecent language or rowdy or objectionable conduct are prohibited and will result in the immediate cancellation of this permit.
12. No dogs or other domesticated animals are allowed in the parks, playgrounds and indoor facilities.
13. Articles and equipment belonging to the Borough must be returned promptly and in good order. Articles subjected to wear and tear, beyond that which reasonably would be expected, must be replaced.
14. All park, community center and meeting facilities must be left in good order and condition. The judgment of the Department of Recreation as to whether this has been done, as well as whether Borough property is in proper condition to be used, shall be final.
15. Athletic field users shall park vehicles in designated parking areas and refrain from parking on municipal streets. Disregard of this condition will result in the cancellation of this permit.
16. No permit shall be issued unless written application is made to the Department of Recreation at least 48 hours before the intended use of a facility.
17. Any person who shall violate any of the provisions of Chapter 151 of the Marcus Hook Code or any of the provisions hereby set forth shall be liable, on conviction, to a fine or penalty of up to the maximum amount provided by state statute for, each and every offense, and shall be subject to the temporary or permanent suspension of permit privileges.
